Dear Prospective Member,

The Association must comply with **National Privacy legislation**. All personal data you provide us with is collated on national data base, maintained by officers of the Association. Periodically and upon request by affiliated State Associations, we distribute all or part of the data to our State Associations. Generally, the data distributed by the National Association only includes particulars of members and boats in that State. Occasionally, wider data is provided in response to a request by a State Association. The data is used for mail-out of newsletters and other information that we determine may be of interest to our members. We are obliged at all times to disclose the data to relevant statutory and legal authorities on demand.

We will provide available particulars of boat ownership from the database to members upon request. These particulars are limited to Boat/Sail number, class, member number, boat name, construction, previous owner's name, date sold, date entered, State and ownership status (current, sold).

Generally, we do not provide members address, telephone or Email contact details to other members. However, at the discretion of the Committee, we will provide available contact particulars of Members to other Members but only after:

- (1) appropriate request, and
- (2) the Secretary or Registrar of the relevant State or National Association has first obtained the express permission of a Member to disclosure of his or her private information.

In applying for membership, you expressly consent to our use of your personal information for these purposes.

You are entitled to access our database upon prior request on reasonable notice to check and amend your personal particulars. The Executive Committee of the Association urges your consent, to facilitate the purposes of our Association.
